Inland Water Transport, Assam invites applications for examination & subsequently for awarding of "*Certificate of Competency*" on successful completion of selection criteria. Candidates have to be citizen of India. Examination will be conducted for the following categories of in service crews:

- 2nd Class Engine Driver Certificate
- 1st Class Engine Driver Certificate
- License Engine Driver Certificate
- Serang Certificate
- 2nd Class Master Certificate
- 1st Class Master Certificate

Examination fee Rs.100/-

Fee should be paid by Demand Draft drawn in favour of "*Director, IWT, Assam*". Demand draft should be submitted along with the application.

Age:-

The age of the candidate should not be less than (Age on the 1st January'2018)

- 21 (twenty one) years for Serang.
- 22(twenty two) years for 2nd Class Engine Driver/ 2nd Class Master.
- 24(twenty four) years for 1st Class Master.
- 25(twenty five) for years for 1st Class Engine Driver.
- 28 (twenty eight) years for Licensed Engine Driver.

Educational qualification :-

- a. The applicant should have successfully cleared class IX. The age limit of the candidates will be calculated on the basis of the School /Institution leaving Certificate issued by a recognized Board/ Council and Birth Certificate issued by Govt. No other document shall be accepted in lieu thereof for the purpose. It is mandatory for the candidates to submit minimum their class IX passing certificate or higher qualifications.
- b. The candidates must possess minimum 3 (three) years Sea Service Certificate (Experience Certificate) from the employer where he worked. Signature of only authorised signatories of the employer will be accepted. Sea service certificate should be on original letter head containing valid E-mail and phone number of the company and duly stamped.
- c. Candidates applying for the examination are required to submit the certificate of Fitness and Eye sight test from registered Government Doctor.

The decision of the Director Inland Water Transport Assam as to eligibility or otherwise of a candidate for admission to the examination shall be final.

The selection procedure will be conducted in two phases.

The candidates whose applications are accepted will be required to appear in a written test as below:

Phase:II

Viva-voce/Interview: The viva-voce will carry 20 marks.

- The Written test and viva-voce will be held on the same day at the Directorate of IWT, Assam premise.
- The candidates who obtain at least 40% marks in the written examination will be eligible for appearing in the viva-voce.
- The final merit will be made on the basis of total marks secured by the candidate in the written test and the viva-voce interview. Candidates who obtain at least 40% marks in total will be eligible for obtaining the Certificate of Competency.

Note: The candidates will have to bring all the original testimonials i.e Age proof Certificate, Educational

Qualification Certificate, Sea Service Certificate (Experience Certificate) etc. for verification at the time of viva-voce interview.

Candidates will have to use ONLY BLACK BALL PEN.

HOW TO APPLY

- a. *Application form* may be downloaded from the Director, IWT, Assam's website http://iwtdirectorate.assam.gov.in
- b. The name of the Examination/Category applied for should be clearly written in "BOLD LETTERS" in the Envelope containing the application form and it should be addressed to the Director, Inland Water Transport, Assam, Ulubari, Guwahati-781007.

- c. The applicant should submit their application in a sealed envelope and send "through post" only. Application received after the last date of submission i.e 21st May'2018 till 03.00 P.M shall not be accepted under any circumstances for this examination.
 - After verification of application form and documents, a list of eligible candidates along with examination date, time and venue will be uploaded on our website http://iwtdirectorate.assam.gov.in. on 11th June 2018.
- d. Only application which are signed by the candidates and accompanied by all particulars as called for in the application form prescribed by the Director will be accepted. A list showing documents submitted along with application form should be enclosed with signature.

HOW TO FILL UP THE FORM

- a. Applicants must affix 1 (one) copy of recent passport size photograph on the space provided in the application form firmly with good quality glue/adhesive and also should enclose another 2(two) copies along with the application. The Director shall not be responsible for detachment/loss of the photograph.
- b. The applicant shall furnish self-attested copies of Certificates/documents declared by himself to be true copy of the original along with the application.
- c. In case of detection of any false declaration/statement made by any applicant, his application will be rejected and will also be penalized as per Rules/ Law.
