The Directorate, Inland Water Transport (IWT), Govt. of Assam hereby invites online tenders (Technical and Financial Bid) from reputed Marine Engine manufacturers or their experienced authorized Dealers for supply of 10(ten) nos. Marine Diesel Engines for delivery at Silchar, as per details given below. Intending tenderers are required to register at portal of e-tender of the Assam Govt. www.assamtenders.gov.in and participate through the online tender portal only.


Applicant submitting the downloaded version would need to pay the cost of tender document/bid along with the hard copy of Technical Bid through Demand Draft of any Nationalized Bank amounting to Rs.1000/-(Rupees one thousand) only drawn in favor of "Director, Inland Water Transport, Assam" payable at Guwahati (Assam).

1. Tender document will be available on the aforesaid website from 09.01.2019 to 19.01.2019. A signed declaration stating that no alteration has been made in any form in the downloaded tender document / bid is to be enclosed with the tender by bidder for downloaded tenders. The amendment / clarification, if any, to the document will be available on the above website.
2. Tenderer shall agree to the terms & conditions of the tender and submit the tender online.
3. Tender must be accompanied with scanned copy of all documentary evidence of credentials like : attested/ notarized copy of valid Manufacturing License / Trade License/Certificate of authorized dealership, performance certificate, financial performance and all other documents as specified in the tender document.
4. **Eligibility Criteria** : The eligibility criteria for the participation in the tender for above work shall be as follows:
 - A. Bidder/Tenderer shall be a Marine Engine manufacturer/ Authorized Dealers of manufacturer of marine diesel engine and the average annual financial turn-over for last three financial years shall not be less than at least 50 % of estimated cost having experience of successfully supplied Marine Engine and Gear Box in last three years.
 - B. Any Company/Firm which has been blacklisted either by the Tender Inviting Authority or by any State/Central Govt. Department should not participate in the tender.
 - C. Bidder / Tenderer shall have to submit parts catalog and maintenance manual of the product to be supplied with an undertaking that if any deviation with the provision of above requirement will be disqualification.
 - D. Rate shall be offered on per unit basis excluding all taxes, levies and charges etc. Applicable Levies/Cess/GST/Service Charge /Cost of Road Permit /Transportation/ Insurance of Transportation etc. are also to be shown separately in the price bid per unit basis. No offer for part thereof will be considered disqualification and in these circumstances the tender will be treated as cancelled.
5. Tenders must be accompanied by Earnest Money Deposit of **Rs. 60,000/- (Rupees sixty thousand) only** in the form of Demand Draft / Fixed Deposit from any Nationalized Bank of India payable at Guwahati, Assam and drawn in favour of Director, Inland Water Transport, Assam.

6. Tenders must be delivered to the Directorate of Inland Water Transport (IWT), Ulubari, Guwahati-781007 on or before 2.00 p.m. on 19.01.2019. Late tenders will be rejected.

Instruction To Bidders (ITB) including Instruction to the Tenderers / Bidders for the e-submission of the bids online through the Public Procurement Portal for e-procurement of Govt. of Assam.


Intending tenderers are required to register at portal of e-tender of the Assam Govt. www.assamtenders.gov.in and participate through the online tender portal only.

A hard copy of the tender documents along with Financial/ Price bid and the original tender fees & EMD, exactly same as that of online submission are to be submitted to the office of the Director, Inland Water Transport, Assam before the Closing date and time of submission of the tender, i.e by 14.0 hours of 19th Jan '2019.

- 1) Bidder should do the enrolment in the e-Procurement site of www.assamtenders.gov.in. During enrolment/registration, the bidders should provide the correct/true information including valid email id. All the correspondence shall be made directly with the contractors/bidders through email id provided.
- 2) If there are any clarifications needed, this may be obtained online thro' the email or during the pre-bid meeting if any. Bidder should take into account of the corrigendum published before submitting the bids online.
- 3) It is construed that the bidder has read all the terms and conditions before submitting their offer. Bidder should go through the tender schedule carefully and upload the documents as asked, otherwise, the bid will be rejected.
- 4) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/xls/jpg/ formats.
- 5) If there are more than seven documents, they can be clubbed together and can be provided in the requested format.
- 6) Bidder should submit the Tender Fee/ EMD as specified in the tender. Earnest money shall be accepted in the form of Demand Draft/ Fixed Deposit of any Nationalized Bank pledged in favour of "Director, Inland Water Transport, Assam" to be submitted along with the hard copy of the tender at office of the Director, Inland Water Transport, Assam, Ulubari, Guwahati-781007 before the closing time of the tender. Scanned copy of the instrument should be uploaded as part of the offer.
- 7) The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise submitted bid will not be acceptable.
- 8) If the price bid format is provided in a spread sheet file like BOQ the rates offered should be entered in the allotted space only and uploaded after filling the relevant columns. The Price Bid/BOQ template must not be modified/replaced by the bidder, else the bid submitted is liable to be rejected for this tender.

- 9) The bidder should ensure/see that the bid documents submitted should be free from virus and if the documents could not be opened, due to virus, during tender opening, the bid is likely/liable to be rejected.

GENERAL TERMS & CONDITIONS FOR SUPPLY OF MARINE DIESEL ENGINE & GEAR BOX

1. The Tenderer/ Bidder must quote their rates both in figure and word clearly avoiding overwriting / erasing or any change/ cancellation should be properly signed with date.
 - Tenderer/ Bidder may suggest different type of matching 2:1 gear box with rate and detailed particulars of the suitable matching Gear Box will be selected by the department.
2. **Authorization Certificates** : Tenderer must furnish the Authorization Certificates from the manufacturer for marine engines and from concerned manufacturer for Gear Box.
3. **Working Manual** : The detailed working manual and parts catalogs of machineries with details sketch, dimension, clearance, temperature, pressure, etc. of various components should be furnished at the time of delivery. Hand Tools as per requirement must be supplied separately for each engine.
4. **Price** : Tenderer/ Bidder must quote their rates including GST and other charges including free delivery at site at IWT Division Silchar, Assam. The quoted rates shall remain valid at least for a period of 80 days from the date of opening the quotations.
5. **Timeline** : The work is under SOPD-G component for the financial year 2018-19 and the expected time of delivery from the date of placing the supply order should be mentioned by the Tenderer/ Bidder.
6. **Guarantee** : The engine, gear box and other mounted machineries must be guaranteed for a period of at least 12 (twelve) months from the date of delivery and necessary guarantee certificate should be furnished with the supply of Engine, Gear Box and other machineries and accessories.
7. **Execution of order** : Work/ Supply should be executed directly by the successful bidder and not through any other agency.
8. **Road permit** : IWT Assam will not be responsible for arranging Road Permit for transportation of goods. It will be the responsibility of the successful Tenderer/ Bidder to obtain Road Permit from the concerned authority.
9. **Executed Report**: On completion of supply the supplier shall submit delivery challan Report to the Director IWT Assam through the Executive Engineer concerned under whom supervision the supply work executed with duly seal signature.
10. **Payment** :

No advance payment will be made for the work. 90% Payment of contract value will be made only after receiving the materials in full and good conditions satisfactorily, subject to receiving of fund from the Govt. If products are found defective then party concerned have to replace at their own cost. Balance 10% (ten percent) will be paid to the Supplier after satisfactory completion of guarantee period.

11. Financial Soundness certificate:

Bidders /Tenderer must submit financial soundness certificate from concerned Bank or Financial authority indicating present position.

12. Termination of Default :

In case of any violation of contractual terms & conditions by the contractor, the Purchaser (DIWT) without prejudice to any other remedy, may be written notice of default to the contractor, terminate the contract in whole or in part. In the event of termination of the contract in part the contractor shall continue performance of the contract to the extent not terminated.

13. Termination of Insolvency :

The purchaser (DIWT) may at any time terminated the contract by giving written notice to the contractor without compensation to the contractor if he become bankrupt or otherwise insolvent, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.


14. Liquidated Damages :

If the selected Tenderer / Bidder fails to deliver the product /equipments within the period fixed for such delivery the authority may without prejudice to its right to impose penalty for breach of the contract, equivalent to 0.5% of the contract price of the delayed equipment every week delay, subject to maximum of 10% of the contract price.

SPECIAL CONDITIONS OF CONTRACT

1. The Tenderer/ Bidder must submit/enclose the following documents (duly signed) with their quotations.
 - i) Copy of PAN card with I.T. return at least for last 2 (Two) years.
 - ii) Copy of Registration of GST.
 - iii) Copy of GST clearance Certificate.
 - iv) Financially soundness certificate from competent authority.
 - v) Original tender fees being purchase of tender papers.
 - vi) Concern authorized Dealership and Experience Certificates.
 - vii) Certificate of Company /valid manufacturing License by engine manufacturer.
 - viii) Earnest money : Tenderer/ Bidder must deposit Earnest Money of Rs. 60,000/- (Rupees sixty thousand) only in the form of Bank draft / call deposit of any Nationalized Bank of India pledged in favour of the Director IWT, Assam, Guwahati along with quotations, which will be adjusted with the security money in respect to the successful Tenderer.
 - ix) The earnest money of successful tenderer shall be forfeited if he/they failed to abide by the order of full supply within stipulated time period.

2. A complete bed-test report carried out at factory of all Engine & Gearbox / Machineries along with "standard" and "extra" accessories must be furnished (in duplicate) at the time of delivery and the supplier will be fully responsible for any irregular reading etc. Necessary guarantee/warranty certificate for the engines and gear boxes must be accompanied at time of delivery.
3. Payment will be made subject to availability of fund.
4. The supplier is fully responsible for any defect arising out at the time of installation of engine & gear box etc. on board during trial run and the same have to be rectified by the supplier at their own cost.
5. Documents of service Network for availability of spare parts & service/ repair facility are to be mentioned in the quotation.
6. The supplier will be fully responsible for supply of Engine & Gear box with accessories at IWT Division, Chandmari, TV Station Road, Tarapur, Silchar-3.
7. The Director IWT Assam will not liable to accept the lowest rate and may accept or reject any tender without assigning any reason thereof.
8. The successful Tenderer/ Bidder will be required to execute an agreement with required stamp paper at their own cost for the due and proper fulfillment of the contract immediately after placing supply order of as called for without which no payment will be released.
9. The incomplete Tender which don't fulfill the required condition are liable to be rejected summarily.
10. The jurisdictions of all legal proceedings in any matter arising out during tendering shall be at Guwahati only.


