**CORRIGENDUM**

The re-notice inviting tender for "Construction of 16 (sixteen) nos. of 25.0 m long steel Floating Terminals for 16 ghat banks on the river Brahmaputra under 100% Central Sector Scheme" vide No. DWT(T)-50/2017-18/159 dtd. 4<sup>th</sup> March'2019 is partially modified. Please read the "Approved Project Cost" for 16 (sixteen) nos. 
