- In the Data Sheet given in the portal [www.assamtenders.gov.in](http://www.assamtenders.gov.in) the total Bid Security amount for both packages has been inadvertently mentioned as Rs 12,00,00,000.00 (Rupees Twelve Crores) due to typographical error. The correct amount is mentioned in the published detailed bid document and subsequent Corrigendum and is once again stated in Paragraph above.

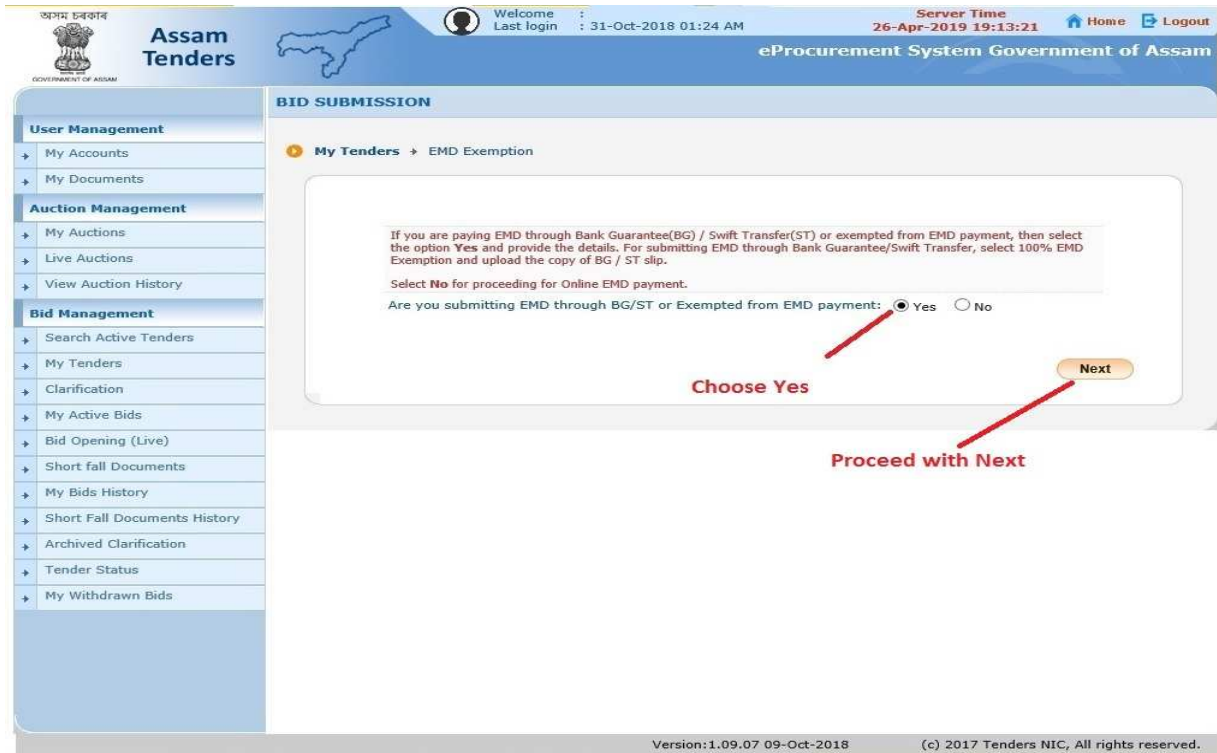

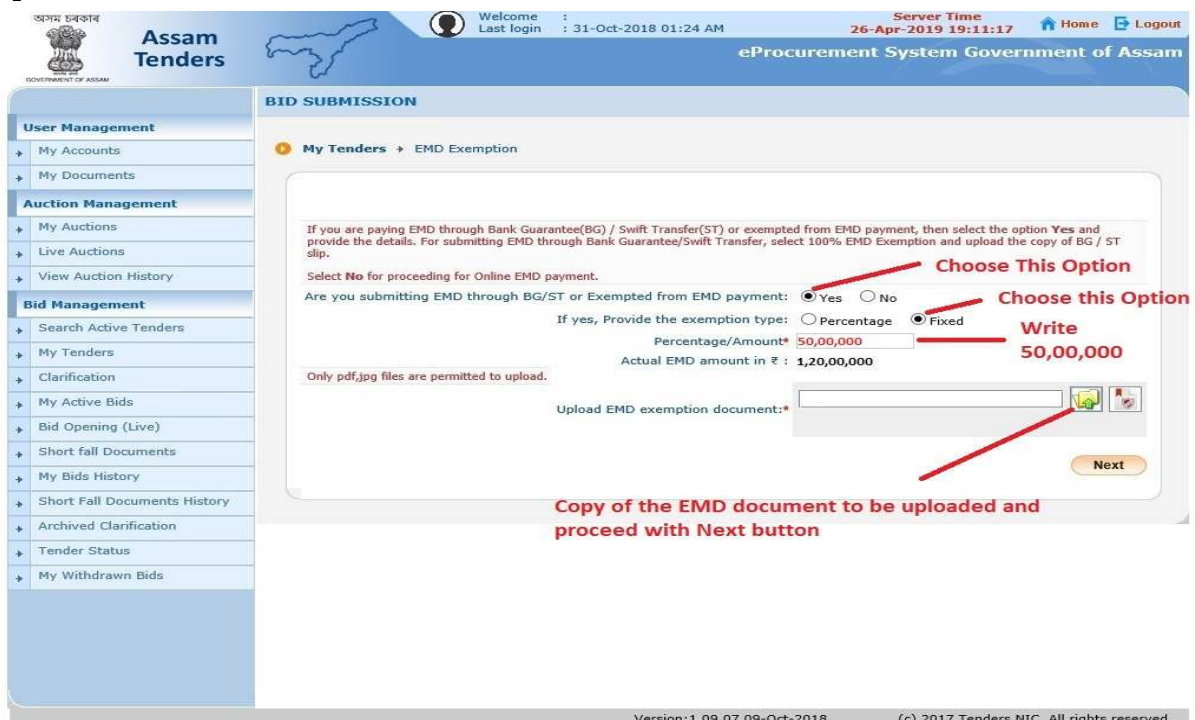
