Aerial Drone (RPA) Survey of Assam Inland Water Transport Project

1. Introduction

The Brahmaputra, running through the heart of the state of Assam, provides a vital link for both urban and rural ferry services which are the single most important transport mode for many section of the population, especially rural households in Assam. These ferry services are provided by the Directorate of Inland Waterway Transport Assam, and by country boat operators – typically small independent and informal private businesses. In addition to the 104 ferry service routes designated by the Directorate of IWT, there are numerous routes licensed by the local (village) and district councils. Other users of the river include the Central Inland Water Corporation Limited (a Government of India Undertaking transporting cargo and operating some terminals on the rivers in the Eastern India & North-Eastern India and on the Indo-Bangladesh protocol routes), border security forces, tourist organizations and private operators.

Now, the Government of Assam (GoA) proposes through the World Bank-financed Assam Inland Water Transport Project, to invest an amount of US\$ 120 million in improvement of the quality of Inland Water Transport (IWT) services along with integration of high quality passenger and vehicle ferry services into Assam's wider transport network system. These investments will no doubt bring economic benefits to the region, with specific interventions contemplated to benefit women and children, other marginalised groups within the local communities, giving them an opportunity for greater participation and their empowerment as users of improved and safer IWT.

2. Drone: Drone here means **<u>Remotely Piloted Aircraft (RPA)</u>** only.

Photography Radius: The camera should capture/cover an area of 1.5 km in diameter ground area. If needed the drone should be able to climb higher altitude so that the desired area of 1.5 km in diameter is captured both in still photography as well as motion picture. The drone has to capture still photos in an interval of every 50 meters in altitude as it climbs upward and while coming downward.

RPA in this survey should have a camera for still photography as well as motion picture. Both the cameras (Still and motion picture) should be of Full HD. It should be able to capture in vertical, Oblique (High Oblique and Low Oblique) as well as Combination (360°).

The Drone should be able to remain airborne for a minimum period of 30 minutes.

3. Project Objective:

The Assam Inland Water Transport Development Society intends to carry out detailed aerial drone survey & assessment of identified terminals (as indicated Annexure 1) which shall provide a 360 degree detailed and quality view of the site condition. This survey shall help in understanding such ferry terminal locations dispersed over large area and animated video based on concept terminal designs on the proposed locations.

4. Scope of work

- a. The scope shall cover carrying out aerial topographic survey of existing situation of ghats. (20 Nos As listed in Table -1.)
- b. The survey shall be carried out for an area of
 - i. 1 Km upstream and 0.5 Km downstream side of existing terminal/ghats along the length of the river and
 - ii. 1 Km along width (0.2 Km on river side and 0.8 Km on land side).
- c. Prepare illustrative image projection in form of video for proposed development works along these 20 Ghats. This video shall help in also visualizing the proposed development works including terminals, river protection works, access roads, terminals, vessel boarding, de boarding, navigation aids at the locations & routes.
- d. The existing ferry locations are mentioned below in Table-1.
- e. For each terminal location provided by clients, animated 3D structures should be shown in the video.

Part A: Video of individual sites which shall include all the details mentioned in above points b), c) and d)

Part B: This shall be a combination of individually playable sections of the proposed Ghats for terminal developments, along with it, 3D animated progress of the terminals. The video would be a combination of images, video clippings, animation etc.

5. Deliverables

- a) Video capturing the essence of proposed terminal locations as illustrated in the scope of work in addition to individually playable sections.
- b) 10 copies of the video in a DVD format/ flash drives and stored in our Server Space.
- c) Raw footage of the video and the tapes used during the filming should be stored in our Server Space.
- d) All copyright for videos, photos and raw footage will belong to AIWTDS.

6. Timeline

The production of the videos approved by AIWTDS should be completed within 6 weeks from issue of work order.

7. Terms & Conditions

- I. The agency will arrange and prepare the tools for aerial drone survey and ensure all clearances required to conduct these videos and surveys in necessary location. The agency will visit selected field sites and other locations for drone survey. The agency will also be responsible for editing the clips to put together a video.
- II. The video:

- a) Should be rendered in a highly engaging format
- b) Should be made in a format which is compatible for both small and large screens and can be viewed without any stuttering
- c) Should be done with voiceover in English and Assamese language
- d) Should be high resolution video and provided in suitable format to AIWTDS
