- The quotationer/ bidder may be an Individual (Proprietorship), Company, Partnership, Trust, Associations or a Society. Suitable documentary evidence/proof like partnership deeds, Certificate of incorporation, Registration of Company etc. shall be submitted.
- The interested t quotationer /bidders must have a good track record and must not have been black-listed by any Government Organization/PSU/Statutory Body/Major Ports in the last five years.
- The Bidder must have an average financial turnover of INR 200 lakh in the last 3(three) years. The same shall be certified by the Chartered Accountant/ Competent authority.
- The successful quotationer/bidder will be liable to complete the remaining balance work of the incomplete 65.0m long Barge at his/their own cost which will not be adjustment for hire charges Construction /repairing /refurbishment of incomplete self-Carrier Barge have to be made available for inspection at anytime of the Owner.
- Constituent of bidders cannot be changed during the lease period of Self-carrier Barge. Any change made for legal purpose before completion of subject agreement, the liability & responsibility shall rest with the remaining constituent (s) or successor /assignee of the original constituent with prior permission of IWT.
- Successful bidder must be ready for long term commitment with adherence to strict quality control and maintenance of the 65.0m long self carrier Barge.
- The firms/individuals fulfilling the eligibility criteria as enumerated here under and also having valid Trade License or Registration of company and proof of submission of Return of GST, Income Tax, labour cess and Provident Fund for last 3(three) years.

In the proposal, parties may clearly state their views for refurbishment of the barge, any renovation / modification proposed (if required).

- The quotationer/bidders shall highlighted previous experiences of vessel construction/ restructuring, operation as well as business through water transportation will be preferred.
- Participants will be shortlisted on the basis of their supporting documents.
- The successful bidder shall be responsible for all activities related to construction of remaining work up to commissioning of the Barge and its use for cargo transportation/storage on NW-1 or NW-2.
- Taking possession of the incomplete self-carrier barge from IWT Assam in "as is where is condition" and shifting to a suitable place of their choice for completion works.
- Arrangement for engaging Naval Architect to assess the BOQ of balance work.
- Preparation of drawing & estimation of balance works indicating timeline up-to commissioning of the same for submission to the Director, IWT Assam for approval after duly vetted by the Naval Architect.
- Seeking prior approval from IWT Assam for modification or alteration of the structure of the self carrier barge.
- Ensuring safety of the self carrier Barge as per navigational norms during repairing / renovation and operation.
- Valid documents to be obtained from concerned department for operation of vessel.
- Providing / engaging Crews as per requirement.
- Deposition of Security Money in the form of Bank Guarantee/ Demand Draft from any Nationalised Bank of India.

**GENERAL TERMS & CONDITIONS FOR HIRE-OUT OF ONE 65.0 M LONG, TWIN SCREW, 750 MT  
CAPACITY, SELF-CARRIER INCOMPLETE BARGE**

1. The Quotations/bids must be submitted to the Director IWT Assam Ulubari, Guwahati-7 in sealed envelope super scribing the name of work in the top right hand side of the envelope. Issuance of tender paper /documents will not construe that such quotationers/ bidders are automatically considered qualify.
2. Initial lease period shall be for 10(ten) years. The Lease period will be renewable for another 10 (ten) years subject to mutually agreed Terms & Conditions with increasing the hire charge @15% after completion of every 3(three) years.
3. Successful bidder/quotationer/ party will be required to deposit advance hire charge for a period of 6(six) months as security deposit in the form of Call Deposit/ Fixed Deposit from any nationalized bank of India pledge in favour of Director, IWT Assam.
4. Hire Charge will be applicable on the successful bidder from the date of commissioning after completion of the remaining construction works.
5. For completion of balance construction work of the incomplete barge, successful bidder may follow the original approved drawings of IWT Assam. They have to engage competent Naval Architect for executions of any renovation/modification of incomplete barge propose from their end.
6. The entire construction/renovation work of the incomplete barge have to be completed by successful bidder within the time frame of 1(one) year from the date of possession of the 65M long Barge. Delay on completion in time without valid ground will attract penalty @5% of lease amount per month. In this respect Bar-Chart / CPM Chart of the work vetted by competent Engineer / Naval Architect must be submitted.
7. The Quotationers /bidders must quote their rates in the prescribed "PRICE-BID" format both in figure and word clearly, avoiding overwriting / erasing or any change/ cancellation should be properly signed with date.
8. Quotationers / bidders must quote their rates per month basis excluding GST and other charges which shall be borne by bidder /quotationer as per norms. Taxes and duties if any should be mentioned separately.
9. The bid offered for lease / hiring shall be remain valid at least for a period of 180 days from the date of opening the quotations.
10. Constituent of the firms cannot be changed during the period of hiring of IWT's vessels. However, if the same changes for any legal requirement before the completion of subject Agreement, the liability and responsibility of contract will rest with the remaining constituent (S) or the successor/ assignee of the original constituent (S) with for the prior permission of IWT.
11. **Earnest money** : Bidder/quotationer shall have to deposit earnest money of Rs.50,000/- (Rupees fifty thousand) only in the form of Demand Draft in favour of "The Director, IWT, Assam" payable at Guwahati at any Nationalized / Schedule Bank without which no quotation will be considered for acceptance. The EMD of successful bidder will be adjusted with security deposit money to be paid till the end of lease period.
12. The Bidders / Quotationers must affix / enclose the following documents (duly signed) with their quotations.
  - i) Court fee stamps of Rs. 8.25/- (Rupees eight and paise twenty five ) only .
  - ii) Copy of PAN card with I.T. return at least for last 3 (Three) years.
  - iii) Copy of Registration of GST.
  - iv) Copy of GST clearance Certificate (Up-to date) .
  - v) Financially soundness certificate from competent authority.
  - vi) Banker's Cheque/Demand Draft of Rs. 1000/- (Rupees One Thousand )only being cost of Tender Paper , which is non-refundable.
